**APPLICATION PROCESS FOR EMPLOYMENT**

1. *All applicants who apply for the first time, must provide two (2) pieces of identification, one must include a picture. If you are not a U.S. Citizen, you must also provide a copy of your immigration card and proof of a U.S. Social Security card.*
2. *Are you not the spouse of an MIC member, yet wish to be employed on the Annette Islands Reserve? Then, your employer and/or business owner must sponsor you.*
3. *Please note that your application may be brought to the Metlakatla Police Department for a background check.*
4. *Before you can receive an MIC Employment permit, you must have an approved Resident Permit.*
5. *For the applicant who is not the spouse of a member, the Employment permit allows you to work for one business only per application. The cost for each Employment permit application is fifty-dollars (\$50). If you change employers you must submit a new application.*
6. *All permits are approved on an annual basis and must be renewed every January.*
7. *An MIC member spouse is eligible to sign as the sponsor for an open Employment permit as long as the marriage is in effect and a copy of the marriage certificate is filed with the Secretary. A non-member spouse is able to apply for any job within the Annette Islands Reserve.*
8. *Applicants and Sponsors must read and agree with the rules and regulations of the MIC application process. Signatures are necessary for MIC to complete the application process. Failure to sign below may result in not approving the permit, or slow down the approval process.*
