APPLICATION PROCESS FOR RESIDENCY

- All applicants who apply for the first time, must provide two (2) pieces of identification, one
 must include a picture. If you are not a U.S. Citizen, you must also provide a copy of your
 immigration card and proof of a U.S. Social Security card.
- Are you not the spouse of an MIC member, yet wish to reside on the Annette Islands Reserve? Then, your employer and/or business owner must sponsor you.
- Please note that your application may be brought to the Metlakatla Police Department for a background check.
- Before you can receive an MIC Employment permit, you must have an approved Resident Permit.
- For spouses of members you may be eligible to receive a permanent Resident Card with copies of a Marriage Certificate. Residency may be revoked if a divorce occurs. Proper documentation must be submitted to the MIC Executive Secretary.
- All permits are approved on an annual basis and must be renewed every January.
- In reference to Residency, an MIC Member Spouse is eligible to sign as the sponsor for both the Resident and open Employment Permit Applications as long as the marriage is in effect.
- Applicants and Sponsors must read and agree with the rules and regulations of the MIC application process. Signatures are necessary for MIC to complete the application process. Failure to sign below may result in not approving the permit, or slow down the approval process.

To MIC Council and Executives:

I am submitting herewith my application to be recognized as a Resident of the Annette Islands Reserve and do subscribe to the following principles of good citizenship:

- To be faithful and loyal to the local Government of the Community, the United States of America and the State of Alaska.
